Resolution Supporting Participation in the CNY Stormwater Coalition Staff Services and Education Compliance Assistance Program

Resolution authorizing the items listed below pursuant to requirements of the New York State Pollutant Discharge Elimination System Municipal Separate Storm Sewer System General Permit.

WHEREAS, Town of LaFayette

herein called the "Municipality", after thorough consideration of the various aspects of the problem and consideration of available information, has hereby determined that certain work, as described in Attachment A, herein called the "Project", is desirable, is in the public interest, and is required in order to implement the Project; and

WHEREAS, the Central New York Regional Planning & Development Board, herein called the "Board", has provided program planning and implementation assistance pertaining to the requirements of the New York State Pollutant Discharge Elimination System (SPDES)

Stormwater Phase II General Permit for Municipal Separate Storm Sewer System (MS4) operators since 2002, and

WHEREAS, the Board has proposed staff and education assistance services in support of sustaining the CNY Stormwater Coalition and to provide a regional public education, outreach and training compliance program to reduce municipal staff burdens, ensure consistency, provide widespread priority audience targeting the most efficient use of limited municipal funds by distributing total program costs over a number of entities within a twelve month timeframe as outlined in Attachment B;

NOW, THEREFORE, BE IT RESOLVED BY THE LAFAYETTE TOWN BOARD

- 1. That DANIEL FITZPATRICK, TOWN SUPERVISOR or such person's successor in office is the representative authorized to act in behalf of the Municipality's governing body in all matters related the Project;
- 2. That the Municipality agrees that it will fund its portion of the program cost in the amount of \$3,600, and that those funds will be made available to the Board upon receipt of invoice.
- 3. That one (1) certified copy of this Resolution will be prepared and sent to the Board upon adoption.
- 4. That this Resolution take effect immediately.

D. Award Ropes Course/Apulia Road property to the highest bidder

WHEREAS, the Town Board has considered all offers and finds the highest purchase proposal \$41,000, advanced by Kenny Griffin of 6845 Frank Long Road, Jamesville, New York to be reasonable; and

WHEREAS, the Town has no public use for this excess property and is willing to sell same to Mr. Griffin for the proposed amount of \$41,000; and

WHEREAS, other proposals were received, as follows:

NOW, THEREFORE, BE IT

RESOLVED AND DETERMINED, that the Town Board hereby approves the sale of the aforementioned property to Kenny Griffin for the purchase price of \$41,000; and it is further

RESOLVED AND DETERMINED, that the proposed purchase price of \$41,000 is a reasonable market value for the subject parcel; and it is further

RESOLVED AND DETERMINED, that the Town will not provide a survey or an abstract of title for the property to the buyer; and it is further

RESOLVED AND DETERMINED, that the sale of said property to Mr. Griffin will be subject to the terms and conditions and provisions of the Town's October 1, 2018 Request for Proposals; and it is further

RESOLVED AND DETERMINED, that the Town will provide a quit claim deed to the buyer; and it is further

RESOLVED AND DETERMINED, that this sale of publicly owned Town property is subject to permissive referendum.

6. OPEN COMMUNICATIONS

A. Jeremy Belfield, LaFayette School Superintendent gave a brief summary of the proposed capital improvement project that will be voted on December 13th, 2018 from 1:00PM – 9:00PM at the Jr. and Sr. High School. The 3.1 million dollar project's main focus is on safety in the schools such as additional security cameras, campus notification system upgrades, door hardening, and window hardening. Construction improvements include masonry repointing, stair replacement and site improvements.

The Capital Project cost of \$3,100,070 due to long-range financial planning practices of the District along with state aid and other fiscal factors, is to have no additional tax impact.

Tom Chartrand reports that our interest is quite strong. Tower rent is up about \$16,000 to the good. Court fines are still very low at 30% lower of what they were at this time last year which is concerning. The highway balance of \$88,000 is the balance of the 2017 -2018 snow plowing season and the \$398K is the winter severity payment from the last three years that the county and Dave Knapp were able to secure for us. The budget should be okay at the end of the year. Tom also advised that the Tax Cap is filed with the State. Currently the general budget is at 85%, the highway budget is at 86% and the library budget is at 79%. There are a couple transfers listed below.

Discussion regarding having enough money for the sign, sharing the cost with the Town as both the Library and the Town will be utilizing and benefiting from the sign.
