

RESOLUTION TO ACCEPT EXTENSION OF WINACRE DRIVE.

Resolved that the Town of LaFayette accept from Harold R. Irwin and Eva Mae Irwin for highway purposes the following described property:

All That Tract or Parcel of Land. situate in the Town of LaFayette County of Onondaga and State of New York, being a part of Lot No. 23 of the Onondaga Purchase of 1817 described as follows:

Commencing at the northeast corner of Lot No.21 of the Winacre Tract as designated on a map of "Winacres" made by H. W. Evans, Licensed Surveyor, dated March 29, 1955, and filed in the Onondaga County Clerk's Office June 2, 1955 (Map No.3733) and running thence South 7 degrees 21 minutes 45 seconds West a distance of 175 feet to the southeast corner of said Lot No.21; running thence Southerly on a line curving to the right, said curve having a radius of 15.47 feet, a distance of 14.45 feet to the point of tangent of said curve; running thence South 60 degrees 51 minute 45 seconds West a distance of 58.40 feet to a point of curve; running thence southerly on a line curving to the left said curve having a radius of 115.47 feet, a distance of 107.82 feet to the point of tangent of said curve; running thence southeasterly on a line curving to the left, said curve having a radius of 106.60 feet, a distance of 131.17 feet to the point of tangent of said curve; running thence South 63 degrees 8 minutes 15 second East a distance of 262.34 feet to a point in the westerly line of Sentinel Heights Road; running thence North 7 degrees East along the westerly line of said Road a distance of 53.16 feet; running thence North 63 degrees 8 minutes 15 seconds West a distance of 244.27 feet to a point of curve, running thence northwesterly on a line curving to the right, said curve having a radius of 56.60 feet, a distance of 69.64 feet to the point of tangent of said curve; running thence North 7 degrees 21 minutes 45 seconds East a distance of 288.0 feet to a point of curve; running thence northeasterly on a line curving to the right, said curve having a radius of 65.47 feet a distance of 61.13' feet to the point of tangent of said curve; running thence North 60 degrees 51 minutes 45 seconds East a distance of 58.40 feet to a point of curve; running thence northerly on a line curving to the left, said curve having a radius of 65.47 feet, a distance of 61.15 feet to the southwest corner of Lot No.22 of the Winacres Tract; running thence North 7 degrees 21 minutes 45 seconds East a distance of 175 feet along the westerly side of said Lot No.22 to the northwest corner thereof; running thence North 82 degrees 38 minutes 15 seconds West a distance of 50 feet to the place of beginning.
