Resolved that the Town of LaFayette accept from Harold R. Irwin and Eva Mae Irwin for highway purposes the following described property:

All That Tract or Parcel of Land. situate in the Town of LaFayette County of Onondaga and State of New York, being a part of Lot No. 23 of the Onondaga Purchase of 1817 described as follows:

Commencing at the northeast corner O! Lot No.21 of the Winacre Tract as designated on a map of "Wlnacres" made by H. W. Evans, Licensed Surveyor, dated March 29, 1955, and filed in the Onondaga County Clerk's Office June 2,1955 (Map No.3733) and running thence South 7 degrees 21 minutes 45 seconds West a distance of 175 feet to the southeast corner of said Lot No.21; running thence Southerly on a line curving to the right, said curve having a radius of 15.47 feet, a distance of 14.45 feet to the point of tangent of said curve; running thence South 60 degrees 51 minute 45 seconds West a distance of 58.40 feet to a point of curve; running thence southerly on a line curving to the left said curve having a radius of 115.47 feet, a distance of 107.82 feet to the point of tangent of said curve; running thence southeasterly on a line curving to the left, said curve having a radius of 106.60 feet, a distance of 131.17 feet to the point of tangent of said curve; running thence South 63 degrees 8 minutes 15 second East a distance of 262.34 feet to a point in the westerly line of Sentinel Heights Road; running thence North 7 degrees East along the westerly line of said Road a distance of 53.16 feet; running thence North 63 degrees 8 minutes 15 seconds West a distance of 244.27 feet to a point of curve, running thence northwesterly on a line curving to the right, said curve having a radius of 56.60 feet, a distance of 69.64 feet to the point of tangent of said curve; running thence North 7 degrees 21 minutes 45 seconds East a distance of 288.0 feet to a point of curve; running thence northeasterly on a line curvlng to the right, said curve having a radius of 65.47 feet a distance of 61.13' feet to the point of tangent of said curve; running thence North 60 degrees 51

minutes 45 seconds East a distance of 58.40 feet to a point of curve; running thence northerly on a line curving to the left, said curve having a radius of 65.47 feet, a distance of 61.15 fee to the southwest corner of Lot No.22 of the Winacres Tract; running thence North 7 degrees 21 minutes 45 seconds East a distance of 175 feet along the westerly side of said Lot No.22 to the northwest corner thereof; running thence North 82 degrees 38 minutes 15 seconds West a distance of 50 feet to the place of beginning.
