TRAFFIC ORDINANCE

OF THE

TOWN OF LAFAYETTE

The Town Board of the Town of LaFayette, in the County of Onondaga, state of New York, pursuant to the provisions of the Vehicle and Traffic Law of the state of New York, does hereby enact the following ordinance to regulate traffic upon the highways within the corporate limits of the Town of LaFayette, said ordinance to be known as the "Traffic Ordinance of the Town of LaFayette".

ARTICLE I. WORDS AND PHRASES DEFINED

Section 1. Definition of words and phrases.

(a) The words and phrases used in this ordinance shall for the purpose of this ordinance have the meanings respectively ascribed to them by Article l of the Vehicle and Traffic Law of the State of New York.

ARTICLE II. STOPPING, STANDING AND PARKING

Section 20. Application Qf Article. The provisions or this article shall apply except when it is necessary to stop a vehicle to avoid conflict with other traffic or in compliance with the directions of a police officer or official traffic control device.

Section 21. Stopping, standing or parking prohibited in designated locations.

- (a) The stopping, standing or parking of vehicles is hereby prohibited in any of the following locations:
 - 1. On both sides of Jamesville-Apulia Road between the Coye Road intersection and the north boundary of the Crolick residence.
 - 2. On both sides of Jamesville-Apulia Road from the north line of the Virgil White farm north to the Erie Lackawanna Railroad crossing.
 - 3. On both sides of West Shore Manor Road.

ARTICLE III. REMOVAL AND STORAGE OF VVEHICLES.

(a) When any vehicle is parked or abandoned on any highway within this Town where stopping, standing or parking is prohibited, said vehicle may be removed by the Highway Department of the Town of LaFayette or by any police officer.

Section 31. Storage and Charges. After removal of any vehicle as provided in this article, the Highway Department of the Town of LaFayette or the police officer may store such vehicle in a suitable place at the expense of the owner of the vehicle. Such owner or person in charge of the vehicle, may redeem the same upon payment to the Highway Department of the Town of LaFayette of the amount of all expenses actually and necessarily incurred in effecting such removal, such charges not to exceed \$25.00, together with any charges for storage, such storage charges not to exceed \$2.00 per day, or fraction thereof.

Section 32. Notice of Removal. The Highway Department of the Town of LaFayette or the police officer shall without delay report removal and the disposition of any vehicle moved as provided in this article to the office of the Sheriff of the County of Onondaga.

ARTICLE VIII REPEAL OF PRIOR ORDINANCES.

Section 80. Ordinances Repealed. All prior ordinances or parts of ordinances of this Town regulating stopping, standing, parking or abandonment of vehicles are hereby repealed, except that this repeal shall affect or prevent the prosecution or punishment of any person[for any act done or committed in violation of any ordinance hereby repealed prior to the taking effect of this ordinance.

ARTICLE IX. EFFECT OF ORDINANCE.

Section 90. Constitutionality. If any part or parts of this ordinance are for any reason held to be invalid, such decision shall not affect the validity of the remaining portions of this ordinance.

Section 91. Time to Take Effect.

- (b) This ordinance shall take effect from and after the 3rd day of July, 1967, except those parts, if any, which are subject to approval under Section 1684 of the Vehicle and Traffic Law of the State of New York.
- (b) Any part or parts of this ordinance which are subject to approval under Section 1684 of the Vehicle and Traffic Law shall take effect from and after the day on which approval in writing in received from both the New York state Traffic Commission and the New Department of Public Works.
