5. REPORTS

A. Departmental

1. Town Supervisor Report

a. Budget Officer Tom Chartrand submitted the Monthly Financial Report, and advised of the following; there are no transfers of appropriations at this time as the 2018 bills are still coming in. Revenues are above normal thanks to the additional rent from the cell tower and interest accumulated at the end of the year from NYCLASS. Mortgage tax is up \$30,000 overall in revenue; general fund up \$68,000 and Highway Fund up \$420,00 due to the winter severity over the last 3 years. Tom will have more financial details next month after all the 2018 end of the year reports are in.

Supervisor Fitzpatrick thanked Dave Knapp for all his efforts with spear heading the increase winter severity item.

2. Highway Superintendent - written report read by John Greeley

Roads: The Highway Department plowed 28 times since last TB meeting. I would like to compliment the Highway guys on a fantastic job this morning. Onondaga County received about ¼" of ice. They started at 2 am under extremely slippery condition and treated town roads with no serious incidences. They assisted several residents who were in the ditch and also helped a County Sheriff in need.

Equipment: The 2019 Ford F-550 has been ordered. Pain restoration on various pieces of equipment is ongoing as weather permits.

NYS DOT: On Thursday January 3rd, the LaFayette residency had a diesel fuel tank that exploded. No serious injuries occurred, however they have no fuel tank to use currently. The resident engineer asked if they could use the Highway's fuel facility to expedite the fueling process and get on the highway sooner. Since the Highway Department already has s "shared services" contract with the NYS DOT, I had the attorneys amend the contract to allow the state to use our Facility. They will replace all fuel used and in return the NYS DOT would give back 10% fuel to cover administration and fuel treatment costs. This amendment is valid for the existing time of the original annual contract.

Important dates for 2019 to remember: Brush pick-up – April 1 thru April 19th Earth Days – Friday April 19th and Saturday April 20th; Town clean-up days – Saturday May 4th – May 11th.

Councilor McConnell moved and Fitzpatrick seconded the motion approving Amendment # 1to the Shared Services Contract, dated August 13, 2018, between the People of the State of New York/NYSDOT and the Town of LaFayette. Motion carried. 4 - 0.

3. Town Clerk

Review.

4. Building and Code Enforcement – Town Clerk Jackie Roorda advised that Code Enforcer Ralph Lamson had to leave after the Organizational Meeting however he has provided the entire list of building permits issued in 2018.

b. Monthly checklist review/audit of Justice Perrin and Justice Shute's court records for September, October and November 2018 were available for the Town Board's review prior to the regular meeting.

7. Library

a. Dave Prince reported that the individual whom was going to be a part of the Library Board in now unable to do so, therefore they are looking for someone to fill that Board Trustee position.

b. Prince also thanked Legislator Dave Knapp for assisting and advocating for the Library to receive grant money which was used to upgrade computers, updating

technology, memory and other different computer programs in the Library. Supervisor Fitzpatrick also thanked Dave Knapp for his assistance.

8. LCC

a. Dave Prince advised that Basketball had its first of 6 weeks of games; the ski program had to cancel last Friday due to lack of snow and Song Mountain closing. He advised there are a lot of kids registered to ski; and wrestling has 45 kids involved. After the February break girls volleyball will begin.

Prince also expressed thanks and gratitude for the 65 individuals who had volunteered in 2018 to assist in the running the Community Council programs. These volunteers have given their time and efforts to ensure these sports programs run smoothly.

9. Parks and Recreation – Prince thanked the highway crew for assisting with their lift in getting the lanyard lowered from the 35' flagpole at the Park to allow the flag to be back up and flying.

- B. Committees
 - 1. Environmental

Jeannie Gleisner, Chair of the committee reported that after review of Local Law No.1-2017 it was found that the official title of the committee is LaFayette Advisory Conservation Commission. This gives a clearer knowledge of the legislative intent of the committee/commission, which is for the preservation and quality improvement of the natural and manmade environment of LaFayette. At this time there are only 5 members of the 7 member committee. Gleisner advised they met twice in 2018 and they reviewed the open space detailed geographical map of the town. The map is a great planning tool for the Town.

Gleisner advised that her day job title is Regional Program Manager for Community Development and reported there is possibly \$3,500 grant money the town may qualify for. This includes energy conservation, greenhouse gas, LED lighting, etc. This is a great opportunity for the town to consider and she advised that if they contact her, she can assist by getting them in touch with the individuals who may help with the grant

6. LEGAL - Attorney John Langey advised that we can finalize the sale of the former ropes course at this time, however the Town Board needs to make a motion regarding the money and documents.

Counselor McConnell moved and Zajac seconded the motion authorizing the collection of funds from Ken Griffin and authorizing Supervisor Fitzpatrick to execute all transfer documents necessary to finalize the sale of the Apulia Road property (former Ropes Course) from the Town of LaFayette to Ken Griffin.
