WHEREAS, the Town of LaFayette Town Board desires to create the public office of Town Attorney in order to enhance the efficiency and cost effectiveness of the delivery of legal services to the Town; and

WHEREAS, the general responsibilities of the Town Attorney are to negotiate, prepare, approve and audit written contracts, leases and other legal instruments; attend meetings of the Town Board, Planning Board, Zoning Board of Appeals and the Assessment Grievance Board of Reviews; draft local laws and resolutions for consideration by the Town Board; create or extend special districts; provide legal advice and counsel to the Town Board, Planning Board, Zoning Board of Appeals and the Assessment Grievance Board of Review; and provide litigation services to the Town on an as-needed basis; and

WHEREAS, the accomplishment of the above duties involves the exercise of discretion by the Town Attorney on behalf of the Town of LaFayette.

NOW THEREFORE, BE IT RESOLVED, that the office of Town Attorney is created in the Town of LaFayette; and

BE IT FURTHER RESOLVED, that Jeffrey D. Brown, Esq. is hereby appointed to the position of Town Attorney to perform the above-mentioned responsibilities for a term beginning upon the filing of Local Law No.1 of 2019 with the Secretary of State and ending on December 31, 2019, at an annual salary of \$38,000.00, plus actual out of pocket expenses incurred in providing such services; and

BE IT FURTHER RESOLVED, that the Town Attorney is considered a public officer and as such the Town Attorney shall sign and file an oath of office with the Town Clerk.
