These are the LACC activities between October 7 and November 3, 2022:

- 1. **Membership** No change.

- 3. **Projects & Programs** See attached status summary of projects requested by the Town Supervisor and programs selected to build a community conservation culture. Of note:
 - a. A total of 4 trees and 4 benches have been requested for the Memorial Tree and Bench Program since its launch in August.
 - b. A press release announcing the Town's community solar subscription and savings was reviewed by Town Board and released to the media.
 - c. A new project was started to cover the Clean Energy Community program approved by the Town Board in August. The first activity is to receive formal CEC designation and the \$5k grant from NYSERDA. Follow-on activities are shown in the attached status table.

Meeting Summary – September 27, 2022

Attendees

Introductions

Payton Kremers, as new student member, introduced himself and all other attendees introduced themselves. Craig Archer led a safety moment about ladder safety.

Projects & Programs

Each of the LACC's projects and programs were discussed, as shown in the attached status summary. Below are some of the highlights:

Senior Center - On hold

Parks – Mark Distler said the memorial tree & bench program was released online in mid-August, and since then there were sponsorship requests for 3 trees and 1 bench. Amy Roe explained the upgrades constructed earlier this year at Bailey Park.

EVCS – Mark said he received a quote from the EVCS contractor after a 9-month process. The total cost was \$450k, including \$77k match from Town. He said he was working on a ROI analysis and will get a second quote. He said he recommended the cost in next year's Town budget but thinks we need a completed ROI that we can be confident. He said we need to find and talk with a municipality that has pay-for-use DCFC (fast charge) before we decide to recommend for next year's budget.

Invasive & Hazardous Plants – Kelly Wypych talked about the article she wrote for the Q4 town newsletter. She said the article asked for volunteers to get involved. There was some discussion about identifying focused projects for volunteers via coordination with organizations who identify & mitigate invasives. Kelly said she will provide iMapInvasives webinar or in person training to residents interested in getting involved with this program.

Community Solar – Mark said the Town Board approved a community solar subscription for all of its eligible electric accounts, which is estimated to save \$4.7k each year. He said the Town Board also approved a carbon footprint benchmarking program and community campaign, and it's time to start working on them. He asked for volunteers to help on a campaign scoping document. Volunteers were: Kelly, Amy Roe, Payton Kremers, Larkin Podsiedlik, and Keith Terrell. Mark said that these programs will earn the Town designation as a Clean Energy Community (via NYSERDA), in addition to a \$5k grant to be used on energy reduction projects.

Land Use Independent Study – Mark and Kelly said they received one proposal from a consultant for the study. Three other consultants declined to propose. Mark said he put the cost in the 2023 Town preliminary budget. He mentioned that it may not make it in the final budget given the Town budget is expected to be over the 2% cap.

Enhancement of SEQR – Mark, Kelly and Doug explained how they managed to specify what should be considered as "enhancement" use of SEQRs conducting by the three Town boards. They reported that the Town Attorney and Town Engineer conducted a 20-minute training session with the Town Board and were scheduled to do the same for the Zoning Board of Appeals following the meeting.

CEAs – Amy, Mark and Larkin explained the current activity is to talk with local subject matter experts to ask for input on a draft list of CEAs for the Town. Amy talked about the experts she had recently spoken with. Mark explained how CEAs are used in evaluating new development proposals and how important resident communication and education would be the more critical step in this project.

Tree Planting Program – Rachel, Doug, Mark, Markus, and Keith currently surveying Town properties and developing recommendations for removal, pruning and planting.

Newsletter article – Mark asked for ideas for the 1Q23 newsletter article. Suggestions included invasives, honey bees, and home composting.

New Business

Honey Bees – Payton provided a technical presentation on honey bees, including the threats they face and what humans can do to help them thrive.
