

TOWN OF LAFAYETTE LOCAL LAW NO. 1-2011

A Local Law Amending the Subdivision Regulations of the Town of LaFayette, Originally Adopted by the Town of LaFayette Planning Board on May 12, 1987, Approved by the Town of LaFayette Town Board on July 13, 1987 and Ratified by the Town Board by Local Law 4 of 2007, as Amended

Be it enacted by the Town Board of the Town of LaFayette Town Board, as follows:

- Section 1. Article 5 of the Subdivision Regulations, Titled "Design Standards and Required Improvements", is amended so that the provision titled "Dead End Roads" shall read in its entirety, as follows:
 - "Dead End Roads. Dead-end roads, designed to be so permanently, shall generally not be longer than five hundred (500) feet and shall be provided at the closed end with a turn-around having a street property line diameter of at least one hundred thirty (130) feet or, in the case of a cul-de-sac, have a minimum outside radius of at least sixty (60) feet. The length of a dead-end road may be extended beyond five hundred (500) feet by waiver of the Planning Board pursuant to Section 150 of these Subdivision Regulations, based upon written evidence from the Town Highway Superintendent, the affected school district and the pertinent fire department that the additional length will not pose a safety hazard or interfere with Highway Department or School District services and activities."
- **Section 2.** Article 1 of the Subdivision Regulations, Section 150 thereof is hereby amended to change the title of said section to "Waiver" instead of "Variance".

Section 3. <u>Effective Date.</u>

This local law shall take effect upon its filing with the New York Secretary of State.
