A LOCAL LAW EXTENDING THE MORATORIUM AND PROHIBITION WITHIN THE TOWN OF LAFAYETTE ON NATURAL GAS AND PETROLEUM EXPLORATION AND EXTRACTION ACTIVITIES, UNDERGROUND STORAGE OF NATURAL GAS, AND DISPOSAL OF NATURAL GAS OR PETROLEUM EXTRACTION, EXPLORATION AND PRODUCTION WASTES

Be it enacted by the Town Board of the Town of LaFayette, as follows:

Section 1. The Local Law "Effecting a Moratorium on and Prohibition of Gas and Petroleum Exploration and Extraction Activities, Underground Storage of Natural Gas, and Disposal of Natural Gas or Petroleum Extraction, Exploration, and Production Wastes", originally enacted as Local Law No. 1-2012, is hereby further extended for an additional nine (9) months, until November 13, 2013 or until the Town of LaFayette enacts comprehensive legislation regulating such uses whichever shall first occur.

Section 2. This local law shall take effect immediately.
