

TOWN OF LAFAYETTE 2021 SWIM REGISTRATION IN CONJUNCTION WITH THE TOWN OF POMPEY

The Town of Pompey's Swim Program is being offered to include residents of the Town of LaFayette. Lessons will be held at Cazenovia College's Natatorium and are subject to the college's COVID restrictions for the pool. The Swim Program consists of two separate 3-week sessions. Forty-five (45) minute classes are held every morning, Monday-Friday, for a total of 15 lessons. There are five different time slots, starting at 8 a.m. Copies of the swim schedule will be posted on the Town of Pompey's website (www.townofpompey.org), the LaFayette Community Council's swimming web page (<https://www.townoflafayette.com/swimming.html>), at the Pompey Town Hall, and at the post offices in Pompey and Fabius after June 5th. **Parents must supply all transportation.** There is no fee for Town of LaFayette residents.

ALTHOUGH LESSONS ARE ONLY BEING OFFERED FOR LEVELS IV - VI AT THIS TIME, ALL CHILDREN SHOULD BE PRE-REGISTERED IN THE EVENT THAT RESTRICTIONS ARE EASED AND OTHER LEVEL LESSONS ARE AVAILABLE. THE DEADLINE FOR REGISTRATION IS MAY 31, 2021.
